The Journal of ISSAAS is published semiannually, every June and December, by the International Society for Southeast Asian Agricultural Sciences (ISSAAS), which seeks to encourage the holistic approach to problems and to promote the progress and advancement in science and technology through research and publications, the outcome of which is for regional agricultural development.

Articles published may be invited papers from the presentations at the plenary session of the ISSAAS International Congress or contributed technical papers on tropical agricultural science and related areas including agronomy, forestry, fishery, agricultural economics, crop protection, environmental science, food science, molecular biology and biotechnology, engineering, rural development, agroforestry and other fields related to agriculture.

The code of ethics is designed to maintain high ethical standards relating to the submission, review and publication of invited as well as contributed papers.

Ethical Obligations of Authors

- An author's primary responsibility is to present a concise and accurate account of an original research along with an objective presentation of its importance.
- Authors are considered as those who have significantly contributed to the research and manuscript preparation and assume responsibility for the technical content of the paper. The corresponding author should properly include all co-authors and provide proof that co-authors have seen the final version of the manuscript and have agreed to its submission for publication. Deceased persons who meet the criterion for co-authorship shall be included.
- By submitting a manuscript, the authors agree that the copyrights of their article are transferred to J ISSAAS if and when the article is accepted for publication. If the manuscript contains details including figures from other copyright works it will be the sole author's responsibility to get written permission from the owners of the publishing rights to reproduce such material.

- A submitted article shall contain references to public sources of information sufficient to allow replication and verification.
- The submitted paper shall be free of plagiarism, falsified research data, fabrication or omission of significant information. Plagiarism is defined as the use or presentation of the ideas or words of another person from an existing source without appropriate acknowledgment to that source. By submitting the article to J ISSAAS, the authors agree that J ISSAAS has the legal right to take appropriate action against authors, if fabricated information or plagiarism is discovered.
- Fragmentation of research papers shall be avoided.
- Articles must neither be previously nor simultaneously submitted in any journal nor published elsewhere except in a preliminary form (such as abstract in proceedings, academic thesis).
- Scholarly criticism of a published paper may be justified; however, personal criticism is not considered appropriate.
- Authors should be prompt with their manuscript revisions. The authors should contact the editor as soon as possible if a longer time period is required or they have chosen to withdraw their paper.
- The authors should avoid any potential conflict of interest, e.g., a consulting or financial interest in a company that might be affected by publication of the results.
- Authors should identify the funding source for the conduct of the research and/or preparation of the article in the acknowledgement section.
- After a paper has been accepted, changes can only be made due to a compelling reason. The author must inform the editor, who has the sole authority to approve such changes.

Ethical Obligations of Reviewers

- The double blind peer review shall be conducted in an objective manner and respect the intellectual independence of the author(s).
- Reviewers for each article shall be members of other ISSAAS chapters, other than that of the author, or by other experts in the international scientific community.
- Reviewers are expected to be professional and constructive in their assessment of the interpretation of the data.
- Reviewers shall accept the request for review if they have the qualification and time to judge the article. Otherwise, it is expected that the article shall be returned promptly to the editor.
- Conflict of interest should be avoided by the reviewer. The reviewer shall return the manuscript promptly without review, if ever a potential conflict of interest exists.

- A reviewer should treat a submitted article sent for review as a confidential document. The information should not be used in research of the reviewer nor disseminated without consent of the author.
- The reviewer shall provide the editor the proper context and perspective to decide on the acceptance of the article.
